



**Sheepvention Rural Expo 2024
Ram Sale
Entry conditions and requirements**

1. Only "Pen of 5" or "Pen of 3" flock or stud rams eligible for sale.
2. Vendors must nominate 5 or 3 Rams plus 1 Reserve Ram on their entry form.
3. **The sale will take place on Monday 5 August at 11.00 in the Ram Shed.** There will be **no receivals** of Rams on the Sunday and Monday of Sheepvention. **All Rams MUST arrive by Saturday 3 August prior to 6pm.** Please contact your agent and the Hamilton Pastoral and Agricultural Society office if rams are to arrive prior to Sunday.
4. All rams must be penned and tethered before 8.30 am on Sunday or Monday. **Twine must not be used to either tether sheep or tie up sheep pens.**
5. Provision of containers for feed and water is the vendor's responsibility.
6. Pen of 5 or 3 Rams are to be regulation shorn and AASMB shearing tagged - March shearing (Short wool) and August shearing (Long wool.)
7. Vendors **must** state the breed type and whether Long or Short Wool in the entry application.
8. **Micron Testing:** All sheep must be mid-side sampled in 2024 on the rams current fleece by an authorised testing body. The test results will be included in the ram sale catalogue. A copy of the micron test certificate is to accompany the entry application. Each pens details are to be placed on separate forms. All entry applications and micron testing certificates are to be returned no later than **Tuesday 11 June 2024.** A \$20 administrations fee will be applicable if the forms are not received by the due date. Any vendor amendments are to be made immediately to the Hamilton Pastoral and Agricultural Society.
9. No advertising or additional information is permitted in the Ram Sale pavilion by the Vendors.
10. Vendors are invited to advertise in the Ram Sale Catalogue, see application form for details.
11. The Committee reserves the right to ballot entries if numbers exceed space available.
12. **All entry applications close on Tuesday 11 June 2024, and must be accompanied by:** Animal Health Status National Vendor declaration, including current Gov. Brucellosis accreditation Handlers Waiver Aust. Sheep Johnes Disease MAP Flock Status (If applicable)
13. If no stud history is submitted the previous years will be used. The Hamilton Pastoral and Agricultural Society reserves the right to edit any histories exceeding 150 words due to printing limits. Stud histories must be included in the application form.
14. **Entry fee covers:** Admission Passes, invitation to Exhibitors Function, Media Advertising, Cataloguing and Straw.
